## Report from APDC LLC Fly-in to Juneau

By Tor Anderzen, PE, ASCE On February 9th and 10th. members of ASCE, AIA, ASID, SEAAK traveled to Juneau for a flyin organized by Alaska Professional Design Council (APDC) Legislative Liaison Committee (LLC). We visited with 14 house representatives and nine senators. One of the main topics was House Bill 24 introduced by Rep. Sam Kito of Juneau. Sam is the president of our Juneau Branch. and introduced this bill to extend requirements to use Qualifications Based Selection for procurement of professional services on all state funded projects. Another task was to inform our legislators of the impacts of the FAST Act on Alaska and encourage them to support capital spending on infrastructure projects that leverage federal funds. Another topic near to heart for all of us is support for education programs.

The day before our fly-in the State House halted all hearings on any legislation that is not directly related to our budget crisis, making the priorities very clear. The fiscal reality for Alaska also carried into our conversations about infrastructure needs and wants.

Several of the members of our group also attended a meeting of the Alaska licensing board for Architects, Engineers, & Land Surveyors, giving testimony on a proposed change of regulation affecting the requirements to have a structural engineering license for certain structural designs. We also attended a Budget briefing with DOT&PF, a subcommittee hearing on University

## **Highlights of 50th Annual ASMC**

The Alaska Surveying & Mapping Conference (ASMC) hosted its 50<sup>th</sup> annual conference February 13-19 at the Hilton Anchorage Hotel. The week featured short courses and technical sessions that included special retrospective and historical content, updates on state and national developments, and the latest technology.

The conference keynote luncheon on Tuesday offered reflections on the transition from analog to digital mapping by Allen Carroll, program manager for storytelling at Esri and former chief cartographer at National Geographic. He shared stories about development of some of the National Geographic maps that continue to intrigue and educate people; described his current work creating apps that enable placebased storytelling; and speculated on the future of personal and collective mapping.

Evening social events enhanced opportunities for networking during the week. Monday evening featured a Sponsor and Exhibitor Reception at the Top of the World – the sunset provided a stunning backdrop for locals and visitors alike. Tuesday evening was the Icebreaker Reception in the Exhibit Hall. The Awards Banquet Thursday was a special event this year:

Three geomatics professionals were inducted into the Alaska Surveying and Mapping Conference Hall of Fame at the awards banquet: John F. Bennett, PLS, of R&M Consultants, Inc.; Joseph C. Burch, PLS, retired; and Shari George of Resource Data, Inc. They join a list of 25 individuals who have been

named to the Hall of Fame since the first award in 1995.

Articles about 2016 Hall of fame inductees, and more photographs from the conference, are included inside this issue.

Member organizations of the ASMC are the Alaska Region of the American Society for Photogrammetry & Remote Sensing (ASPRS), the Alaska Chapter of the Urban & Regional Information Systems Association (URISA), the Alaska Section / AAGS, and the Alaska Society of Professional Land Surveyors (ASPLS). The ASMC has coordinated for many years with the Alaska Arc Users Group (AAUG) and UAA Geomatics Student Association (GSA) to co-host the annual conference.

AAUG takes the lead in planning the 3-day GeoJam sessions; and the GSA participates at many levels: GSA provides student volunteers to monitor courses throughout



### John Bennett is Inducted into ASMC Hall of Fame

R&M Senior Land Surveyor John Bennett, PLS, SR/WA, was inducted into the Alaska Surveying & Mapping Conference (ASMC) Hall of Fame at its 50<sup>th</sup> annual conference in February.

"It's a bit overwhelming," said John. "I never considered myself to be in the same class as those who have been inducted before me but now that I see it's a reality, I'm very honored to have been nominated and inducted."

The ASMC Hall of Fame program honors the exemplary contributions of surveying and mapping professionals in Alaska. John was inducted into the Hall of Fame during the ASMC's Annual Awards Banquet on February 18. The Awards Banquet is one event during the weeklong ASMC, the state's largest conference for geographic information systems, surveying and mapping

professionals, which took place February 15-19 at the Hilton Anchorage Hotel in downtown Anchorage.

"During my career I tried to support the profession by participating in efforts to expand a land surveyor's knowledge through class instruction, website development and production of the Standards of Practice manual," said John. "Although my intent was not to seek recognition, my induction indicates that my efforts were appreciated and for that I am thankful."

John is a Senior Land Surveyor at R&M and has more than 30 years of land surveying experience in Alaska. He is based in R&M's Fairbanks office and is responsible for tasks relating to the development of surveys and plans to define existing rights of way (ROW) or new ROW to be acquired by a public agency. Since joining R&M, he has

worked on a variety of airport and highway mapping and title research projects for the Alaska Department of Transportation & Public Facilities (DOT&PF), title research for a gas distribution system in Fairbanks, provided support to the Attorney General's office relating to title and acquisition services, and worked on projects for private clients to resolve title and boundary conflicts.

John commenced his career in surveying and mapping with the Alaska Department of Highways in 1972. He spent 28 years with DOT&PF Northern Region ROW, starting as Titles and Plans Supervisor and ending with almost 15 years as ROW Chief. In that time he managed the title research, surveys, mapping and platting of private and public lands for a variety of DOT&PF highway projects. John is a recognized leader in the research and analysis of historic ROW and has both presented IRWA seminars on the subject and published a definitive guide in the Alaska Society of Professional Land Surveyors Standards of Practice manual. He is also a certified instructor with the International Right of Way Association and has co-presented seminars relating to access law and highway rights of way in Alaska.

Now that John has retired from a management role at DOT&PF, he spends most of his time working on the research and mapping projects he enjoys so much. "I had always considered surveying a great mix of science, law and the outdoors," said John. "But when you focus on right-of-way mapping, you add a strong component of history that can make the research required to map a right-of-way almost addictive."

John holds an AAS in Surveying Technology from the University of Alaska Anchorage. He is a senior

Shari George, a project manager with Resource Data, Inc. (RDI) in Fairbanks, was inducted into the Alaska Surveying and Mapping Conference (ASMC) Hall of Fame at the awards banquet at the 50<sup>th</sup> Annual ASMC.

When informed of her selection she replied, "Wow, I am speechless (well almost)! There are so many deserving people; I am honored and humbled."

Shari has been involved in the Alaska surveying and mapping community since the mid 80s, and for many years has helped plan the ASMC program now known as Geo-Jam, which consists of two tracks of concurrent technical sessions and panel presentations over three days of the week-long conference.

She commented, "It's a continuing pleasure to be involved with the conference and our community – so many wonderful, knowledgeable, creative, hard-working folks. This really makes me happy."

John spends his free time working on his house, pretending to fish and catching up on his reading list of adventure and thriller novels. ❖

sented Shari's award at the banquet, and her husband, Tom George, was at her side. A pictorial chronology of her life accompanied Rick's recap of her journey into remote sensing and mapping.

Shari grew up near
Lake Tahoe and attended
the University of California
Davis, where a class called
Photogrammetry and Aerial
Photo Interpretation eventually led to her first job after
graduation as Lab Research
Assistant at University of
California Berkley, just as
earth resource mapping from
space was starting.

Over the next few years she participated in many interesting projects at UCB, joined the American Society for Photogrammetry and Remote Sensing (ASPRS). and served as ASPRS regional director for the Northern California Region from 1979 – 1985. Her work included projects designed to generate an accurate estimate of irrigation requirements on an annual basis using Landsat for the California Department of Water Resources. It took 7 years at that time. The group succeeded, and received a NASA Space Act Technical Award for Innovative Contribution and a NASA Group Achievement Award.

The group also offered courses periodically in inventory design using satellite remote sensing data, and Shari met a man from Alaska – Tom George – at one of those courses. Six years later, an invitation from Tom to give a talk at the Geophysical Institute about work her group was doing with a Thematic Mapper Simulator brought her to Alaska for the first time. She embraced her Alaskan adventure, and a week after arriving in Fairbanks she headed up the Haul Road for



a hunting trip north of the Brooks Range. Her next adventure was an opportunity to work offshore of the North Slope providing real-time sea ice mapping using airborne SAR to the barge master responsible for a drilling operation. A 1986 photo shows her volunteering at the booth for the Alaska Satellite Facility at the ASMC.

In 1988, she jot a job at the Fairbanks North Star Borough as their first PC coordinator; married Tom George; and they welcomed a son, Kyle, who is now completing his degree at Embry-Riddle Aeronautical University. Two years later, she had an opportunity to manage the Alaska Data Visualization and Analysis Lab (ADVAL) at UAF. "I truly enjoyed my job at the Borough but the chance to get back to my remote sensing and image processing roots was too good to pass up. This was an era when it required special purpose equipment and software to process satellite imagery."

Shari was involved in a variety of interesting projects at UAF,

### Joe Burch is Inducted into ASMC Hall of Fame

Joe Burch, PLS, was inducted in the Alaska Surveying and Mapping Hall of Fame at an awards banquet February 18 during 50<sup>th</sup> Annual Alaska Surveying and Mapping Conference (ASMC). When Hall of Fame Committee Chair Steve Buchanan informed Joe of the honor he replied, "I don't know what to say other than I am humbled by this award."

Joe joins a list of Hall of Fame members that includes some long-



time associates, and one of his earliest mentors, the late Maurice "Ozzie" Oswald, a founding partner of the firm known now as DOWL. In addition to other valuable guidance he provided, Ozzie sent Joe to the ASMC for short courses to expand his knowledge of the profession.

Steve Buchanan, PLS, Past President of the Alaska Society of Professional Land Surveyors (ASPLS) and principal of SurvBase,

LLC, presented Joe's award and shared photos and stories from Joe's 50+ years of surveying in Alaska.

Joe is retired – officially – but continues to serve his profession by helping collect, organize, digitize, and catalog historical survey records, and creating digital archives of ASPLS membership and activities. He spoke during a short course on the history of surveying in Alaska at the

and represented UAF on the Alaska Geographic Data Committee to push for the remapping of Alaska. She also worked with others at UAF and BLM to create the Northern Alaska Spatial Data Users Group, which continues to meet 14 years later. As some functions of ADVAL were assumed by the Geographic Institute of North America (GINA) and other groups at UAF, Shari stepped into roles at the Museum of the North, UAF eLearning and Distance Education and later the Cooperative Extension Service. Then in 2012, she took an opportunity in the private sector with RDI in Fairbanks, where she is a project manager.

2016 ASMC, with a focus on surveying in the '60s and early '70s.

Joe graduated from high school in 1962 and got a job on a survey crew for the City of Anchorage. He continued to work on survey crews for the City of Anchorage during summer breaks from college in 1963 and 1964, and helped on city survey crews after the Great Alaska Earthquake in March 1964, working initially on an area from L Street between 5th and 7th Avenues down to the Alaska Railroad tracks.

Private companies were getting involved in post-earthquake surveys, offering higher wages and overtime than city crews received. Joe's boss and early mentor, the late E. George Fenn, resigned as head of survey for the city when the assembly denied increased funding for the department, and joined D&O (now DOWL). Joe also resigned, and went to work for Alaska Test Lab (which later became part of DOWL). Ozzie became Joe's main mentor after Fenn's death in late 1967, and by 1969 Joe was working full time for DOWL, where he continued until 1973.

In August 1967 Joe accompanied Ozzie to Egegik to survey land under BLM special instructions that had been issued to Harold H. Waller, Deputy U.S. Surveyor. Joe recalls, "I was told that we were surveying land that was identified using the last of the Civil War Script issued 100 years earlier and that Harold Waller was the last living and practicing deputy U.S. Surveyor... I asked questions and Oz answered them and suggested that I purchase a few survey books to understand the professional side of surveying better. After we returned to Anchorage I left for college."

Joe sat for the exam for professional registration in 1971, the first time the national exam was offered

in Alaska, and his original certificate of registration is dated July 28, 1971. He became registered primarily through on-the-job training and some ASMC short courses.

Joe learned in 1971 that his time was limited to complete a bachelor's degree or forfeit credits earned to date. He was close to graduation, so enrolled in college to complete a Bachelor of Arts degree, and started working part-time as an instructor in a 2-year survey program launched by Stan Sears at Anchorage Community College. (Stan Sears was inducted into the Hall of Fame in 2014.) At that time, the nearest school for surveying was Oregon Technical Institute. The University of Alaska Anchorage today has an ABET-accredited and fast growing 4-year geomatics program.

Joe pursued opportunities in the public sector again after leaving DOWL, working for the Department of Defense USAF and the State of Alaska, Department of Natural Resources. He was a division deputy director with ADNR prior to his retirement.

Survey work has taken Joe throughout the state performing roles ranging from "fetch and carry" through chain man, instrument man, and party chief to authority, instructor, and mentor. Since retirement, Joe remains active in professional circles and keeps pace with advances in the profession. •

## **Board Investigation Process 101**

APDC often hears questions about when and how to request a formal investigation or file a complaint in cases of suspected unlicensed or substandard practice. Sometimes the board of APDC or a Member Organization is asked if it can initiate the process. Licensed professionals often know who represents their profession on the AELS Board and ask, can't I just tell an AELS Board member?

The answer to both questions is No. The individual who is harmed by or aware of a potential violation must initiate the action; and members of the AELS Board must recuse themselves from participating in a case if they are informed of a complaint before it comes to them from the Investigator.

The Alaska Department of

Commerce, Community, and Economic Development, Corporations, Business & Professional Licensing Board (AELS Board) website provides clear guidance about how to determine if a complaint is within their jurisdiction, as well as how to file complaints, and how the investigative process works.
